- 4. **Emergency Management Roundtable Exercise** Purpose is to provide forum for discussion and note what is missing in the plan. Provided a scenario and went through the timeline of happenings for each department.
- 5. Discussion and possible action on Referendum questions for Nov. 3, 2020 Election Resolutions #2020-15, #2020-16, #2020-17. Motion made by Stoltz to change Resolution #2020-16 Employee retention/benefits from \$75,000 to \$35,000 for a percentage of 8.7% and \$404,233 levy. Seconded by Hanson. Motion carried 3-1 with Pustina opposed. Rationale for change is not all employees need the health insurance, clerk provided spreadsheet to indicated 2% raise and two employees for health insurance. Motion made by Stoltz to approve Resolution #2020-16 with above changes. Seconded by Hanson. Roll call vote: Stoltz-I; Hanson-I; Reimann-I; Pustina-nay. Motion carried 3-1.

Motion made by Hanson to change Resolution #2020-15 EMT's from \$57,000 to \$75,000 for a percentage of 16.9% and \$444,233 levy. Seconded by Stoltz. Motion carried with Pustina opposed. Rationale for change is the \$57,000 is based on the lowest wage/benefits (\$28,025 x3 EMT's) and if offer higher wages (\$36,880 x3 EMT's) will need to cut other services to make up the difference. Motion made by Hanson to approve Resolution #2020-15 with above changes. Seconded by Stoltz. Roll call vote: Hanson – I; Stoltz -I; Reimann-I; Pustina – nay. Motion carried 3-1.

Motion made by Stoltz to approve Resolution #2020-17 Streets/Capital Equipment as presented. Seconded by Hanson. Roll call vote: Stoltz-I; Hanson-I; Reimann-I; Pustinanav. Motion carried 3-1.
